1. Introduction

This document reports the kick-off meeting of the Erasmus+ Capacity Building in Higher Education project "Curricula innovation in climate-smart urban development based on green and energy efficiency with the non-academic sector" (SmartWB), held at the coordinating the University of Montenegro, on the 23rd and 24th of February 2023. The meeting was hybrid and chaired by Marija Jevrić.

The purpose of the meeting was to:

- Develop a shared understanding of the project objectives, tasks, and expected results;
- Clarify project management and administrative procedures;
- Give an overview of the first project year: work plan and partners' tasks and obligations.

The participants agreed that the Minutes should be brief and focused on essential issues, agreements, and actions to be taken. The kick-off meeting agenda (Annex I), the list of participants (Annex II), and the SmartWB management structure (Annex III) are attached herewith. The meeting agenda was slightly changed at the end of the first day due to the coordinator's suggestion to discuss the text of the Consortium Agreement at the first session on the 24th of February, 2023.

Summary:

The meeting started at 9 am with the SmartWB participants' registration.

Marina Rakočević, the dean of the Faculty of Civil Engineering, University of Montenegro, opened the welcoming session on behalf of the host institution, wishing a successful meeting and a pleasant staying in Montenegro for all guests.

Veselin Mićanović, the vice-rector for education of the University of Montenegro, welcomed the participants on behalf of the University of Montenegro. He shortly presented the mission, vision, and



capacities of the University of Montenegro. He emphasized that the Erasmus+ program has significantly contributed to the internationalization process of the University.

Biljana Šćepanović, the minister for Science and Technological Development of Montenegro, gave opening remarks. She highlighted the importance of this occasion – the kick-off meeting of the first Erasmus+ project coordinated by the Faculty of Civil Engineering, University of Montenegro, being on the path of EU integration and strengthening connections in the region.

Ivana Ćipranić, assistant professor at the Faculty of Civil Engineering, University of Montenegro, presented the project to all participants. The most significant SmartWB segments were highlighted on this occasion, with particular references to the objectives and expected impacts.

Olga Ćalasan, a teaching assistant at the Faculty of Civil Engineering, University of Montenegro, presented the project website and social media networks. Also, she briefly introduced the project management platform, which will be used throughout the project's lifetime. She underlined the need to upload developed outcomes.

Summary:

Marija Jevrić presented the Evaluation Summary Report on behalf of the project coordinator. In addition, a few negative remarks by EACEA evaluators were presented and commented on, highlighting what should be done while implementing some activities to avoid anticipated risks.

Milan Gocić presented the lump sum funding principles and general changes in the reporting rules, in line with the Grant Agreement and the guides for managing lump sum grants available at the EU F&T Portal. He also showed the rules and conditions to be met for amendments to the Grant Agreement.

Dissemination and sustainability of the project were presented by Genti Qirjazi. He explained the primary purpose of this field and highlighted the importance of communication for promoting the project itself and its results to a broader audience. He also emphasized the importance of dissemination activities and the sustainability of some project results after the end of project funding. He underlined the requirements of the Grant agreement, such as visibility of project results, availability of materials produced, and using of the correct logo and disclaimer. All partners should be aware of the penalties in the case of non-compliance with publicity obligations.



Rina Muhaj, the NEO representative, presented CBHE+ projects' operational management rules: the Partnership Agreement, roles and responsibilities of management structure, possible changes to the Grant Agreement, project implementation, and dissemination principles. The discussion's central themes were the grant's financial aspects and possible budget transfers.

Summary:

In this part of the meeting, all partners had a chance to present their institutions and inform the audience about their role in the SmartWB project and their skills and institutional and team potential. While colleagues from the Norwegian University of Life Sciences were present online and presented them through Zoom meeting, another partner, Association of Consulting Engineers of B&H sent a video presentation of the institution and team members.



In addition, all speakers from WB HEIs highlighted the importance of this type of project, especially in capacity development and the establishment of future permanent cooperation.

Marija Jevrić, on behalf of the coordinator, closes the first working day of the meeting, establishing the project management structures: Steering Committee, Project Management Committee, Quality Assurance Committee, and Work packages leaders. All project representatives agreed with the proposed committees.

Summary:

Marija Jevrić presented WP1 - Project management and coordination. She informed partners about the role and responsibilities of the coordinator and beneficiaries in line with the Grant Agreement, as well as future project tasks, activities, deliverables, and deadlines regarding WP1.

At this point, the partners accepted Marija's proposal to discuss the text of the Consortium Agreement that the coordinator had prepared previously and offered partners to analyze and make suggestions. All beneficiaries agreed to use the old template for the Agreement and change it according to the needs of the Consortium in order to have funds transferred earlier and to be able to start with work earlier. After discussion, changes were made to 2 articles. The first installment of the first pre-financing transfer was agreed to be 40% instead of 20%, but with the obligation to use that money to purchase the equipment, among other costs. Another adopted proposal was to add the sentence in Article 8: Budgetary and financial management, about different ways of calculating costs: Costs can be calculated according to the institutional or national procedures or as unit costs or as actual costs. At the end of the discussion, all partners were satisfied with the new version of the text and were asked to send it to their institutions as soon as possible, to be approved by the responsible person.

Doris Damyanovic presented WP2 - Analysis of the current status in climate-smart urban development and underlined the need for joint work to develop all necessary reports on time. Furthermore, she introduced WP2 tasks and task leaders, emphasizing that four different reports



should be prepared, revised, corrected, and uploaded before the workshop, which will be held in Vienna from the 31st of May until the 2nd of June 2023.

Carmen De Pablos Heredero presented WP3 - Capacity building of West Balkans HEIs, highlighting the importance of modernizing curricula according to EU green principles and sustainable development in collaboration with the industry sector. The other tasks are to provide guidance for students' internships in private companies and train teaching staff in new and innovative teaching methodologies for acquiring new practical skills. In addition, each WB partner needs to provide a list of courses in the relevant field they want to modernize and its ECTS catalog in English.

Željko Bačić and Milan Gocić did presentations of 3-day theme-based training events. Venues were announced, and draft agendas were given for two events organized by the University of Zagreb and the University of Niš. One will be held in Dubrovnik from the 9th to the 11th of May, and the other in Niš, from the 14th to the 16th of June.

Agim Kasaj presented WP4 - Creating the technological platform. After completing two tasks - introduction with innovative technological solutions and analyzing industry sector needs for green jobs and climate-smart solutions - they will be able to work to develop the technological platform, an interactive and user-friendly tool not only for the SmartWB project but also for all stakeholders.

After a short discussion, all agreed that WB partners in communication with EU partners should define questionnaire, perform survey and analyze data obtained from the non-academic sector.

Emina Hadžić presented WP5 - Implementation of modernized courses and platform. Innovative learning and teaching methods should be implemented with students enrolled. In addition, 35 students' internships will be organized at WB companies related to the urban development and planning sector. The platform will be used for achieving business-academia collaboration and cooperation. Self-evaluation of implemented university courses will be done as the last task.

Milan Gocic prepared a presentation on WP6 - Quality assurance and monitoring, highlighting the importance of a complete understanding of what is being requested and strong collaboration and commitment from the partners.

Genti Qirjazi presented WP7 - Impact and dissemination. He underlined the dissemination and exploitation issues and the need for the preparation of the Dissemination and Exploitation Plan, which includes round tables with the non-academic sector to promote environmentally conscious urban development, workshops for promoting green job opportunities in urban development, and promotion of using emission reduction approaches and low carbon technologies.

Milan Gocic, at the end of the kick-off meeting, summarized project activities, work plan, tasks, and obligations of the partners for all three years of project duration but gave a detailed overview of the first project year, highlighting deadlines for deliverables expected.
